

A Year into the Pandemic:

Parents' Perspectives on Academics, State Assessments, and Education

MARCH 2021







Research Objectives

This survey was designed to:

Explore parents' perspectives on their children's education this year

Determine how parents' perceptions of their child's performance changed a year into the pandemic

Gauge parents' positions on administering state assessments this spring and the role of assessments in helping parents support their children's education

Key Insights



Increased Engagement Does Not Equate to Increased Confidence

Fewer parents have a clear understanding of their child's achievement compared to previous years.



Parents Question Their Child's Academic **Achievement and Preparedness for the Next Grade**

Only a slim majority of parents believe their children are well-prepared for the next grade.



A Majority of Parents Support Giving End-of-Year Tests

Yet, most parents see both the benefits and challenges unique to this school year.

Methodology



National Online Parent Survey:

Nationwide sample of 1,550 parents and guardians with children in public school, grades K-12, including

- 666 elementary school parents
- 364 middle school parents
- 520 high school parents
- 453 Black parents
- 440 Hispanic parents representing a mix of acculturation levels




- Fielded January 21- February 2, 2021
- Offered in both English and Spanish
- Data were weighted to be representative of publicschool parents in the U.S.
- Research design was informed by past qualitative (focus groups) and quantitative research conducted for National PTA and Learning Heroes

To gauge parent mindset trends over time, the report includes data from past Learning Heroes national studies in April 2020, 2019, and 2018. ▲ ▼ indicate statistically significant differences from past data.

Throughout this report, **blue/red** indicates statistically **higher/lower** differences between audiences


Majorities of Black and Hispanic Children Were Remote



63% Changed between modes at least once

Hispanic parents are most likely to say their children do not have reliable internet access at home.




Parents' Experiences with Learning During the Pandemic

Regarding the coronavirus situation, how much do you worry about...?




Yet, More Connection Doesn't Translate into More Confidence

67% Agree


I am more connected with my child's day-to-day education now than ever before

Half of Parents Report Improvement in Learning in Last Year






Those **missing all technology** are less likely to indicate improvement across all areas. Those with **HH incomes \$100k+** are **more likely** to indicate improvement across all areas.

Believe Child is Achieving At/Above Grade Level




Despite parents being more engaged, their confidence in their understanding of their child's achievement is at an all time low. What do you think are some reasons for this?



Parent Views on End of Year State Assessments



End Of Year Assessments Help Paint the Picture



My child's results from the year-end tests help me know if my child is on track for the next grade

A majority of parents across all key demographic groups (E.g., race, ethnicity, income, gender, online/tech access) agree.

MOST Likely to Agree:


- Hispanic parents (72%)
- Urban parents (72%)
- PTA-involved parents (77%)
- Democrats (73%)

We as parents need to see where our children stand academically...Allowing them to take these tests will allow us as parents or teachers to know and address any issues our children have on learning [as a result of] this stressful time. -- Open-end response.

Parents Favor End-of-Year State Testing this Spring

Overall support is higher among Hispanic parents (57%) than Black (49%) or white (51%) parents.


Do you favor or oppose schools conducting year-end state testing this Spring (Spring 2021) to measure the pandemic's impact on student learning?



Parents Want Timely and Actionable Information


Lowering the stakes is especially important to those initially opposed to testing this year and parents of color. To parents, it is more important to lower the stakes for students than schools or teachers.

How important is each change for this year's state test?




While Parents See the Benefits of State Tests, They Question Test Accuracy Given This Past Year

Looking across statements about potential benefits and potential challenges, we created an index to form a more realistic picture of where parents might land when given more information.





Parents See Both Sides of the Testing Debate



To Make Tests Valuable, Parents Want Results Back with Resources Before the End of the Year


How important is each change is for this year's state test?

Extremely/Very important		Leans Challenges	Neutral	Leans Benefits
Results from this year's state tests would include resources parents can use at home with their child to review concepts where their child may have struggled	76%	79%	69%	81%
Parents and schools would receive their child's scores before the end of this school year	69%	70%	63%	76%
Results from this year's year-end state tests would not affect student grades nor promotion to the next grade level	67%	77%	64%	58%
Results from this year's year-end state tests would not be used to grade schools	56%	66%	54%	44%
This year's year-end state tests would be shorter than they are in a typical year	52%	60%	52%	46%
Results from this year's year-end state tests would not be used to evaluate teachers	51%	61%	46%	42%


Support for State Tests Increases After Exposure to **Benefits and Challenges**

Communications and Strategic Implications



Year-end assessments should be about helping children

☆ Messaging must include how year-end tests will help children while minimizing stress and will not penalize a child for this difficult year (i.e., lower the stakes).



Acknowledge the roller coaster ride parents have experienced and keep a consistent drumbeat of communication

☆ Parents continue to look for the contin clarity and decisiveness. Continue to communicate important info, especially about the state test.



Listen to parent needs before creating summer programs

☆ Majorities of parents recognize their children are behind, but they want a break from school, but they are more worried about social interactions.
